CAPITAL VALLEY CONFERENCE GOLF BY-LAWS

ADOPTED BY THE CVC ATHLETIC BOARD: April 19, 2010 LAST REVISED: January 21, 2016

Section 1 - Starting Date

- 1.1 The dates for the first day of practice, first scrimmage, first contest and last contest are determined by the Section.
- 1.2 A coaches meeting shall be held prior to the first allowable contest. *Adopted: January 11, 2012*

Section 2 - Official Rules

2.1 The official rule book shall be the United States Golf Association Rule Book.

Section 3 - Official Ball

3.1 The official ball shall be any ball conforming to USGA specifications.

Section 4 - Contacts

4.1 The number of contacts allowed is determined by the Section.

Section 5 - Meet Times

- 5.1 Game times shall be indicated on the officially adopted league schedule.
 - 5.1.1 Host school shall secure four starting times for the opposing school. *Revised April 12, 2011*
- 5.2 Starting time for all league tournaments shall be determined by the course.
- 5.3 During the month of October matches may start at 3:00 PM.

Section 6 - Meet Results

- 6.1 The home school shall be responsible to notify the media with game results.
- 6.2 The home school shall be responsible to notify the golf coordinator with complete results.

Section 7 - Championship

- 7.1 Each team will consist of six players. The five best scores will count toward the final team score. If a tie exists when the scores of the five players are counted, the sixth player's score will be added. If a tie still exists after the sixth player's scores are added, the match will be declared a tie.
- 7.2 Teams will earn one (1) point for every dual match win, one half point (1/2) for a tie, zero (0) points for a loss, and one (1) point for each team they beat in the league tournaments. League tournament points will be awarded, with all ties broken by using the 6^{th} players score then via a sudden-death extra hole or holes between all teams tied. The league championship is awarded to the team finishing the year with the most points. *Revised August 19, 2015*
- 7.3 In the event of a tie for the most points, a co-championship will be awarded and duplicate awards presented.
- 7.4 There will be no league standings or championships below the varsity level.

Section 8 - Playoffs

- 8.1 The teams with the highest number of points in championship play will qualify for the Section Playoffs.
- 8.2 Team Tie Breakers If more teams are tied than qualifying berths available after the final league tournament, the following process will be used to determine the qualifiers. The process does not change the standings in any way.
 - 8.2.1 First tie breaker: Add the total score of the top five finishers for both league tournaments. The team with the lowest score advances.
 - 8.2.2 Second tie breaker: Play a nine hole match on a neutral course, with the winner advancing.

Section 9- Conduct

- 9.1 Unsportsmanlike Conduct
 - 9.1.1 Includes use of profanity, club throwing, possession of any electronic communication device or other unacceptable behavior.
 - 9.1.1.1 First offense: 2 stroke penalty.
 - 9.1.1.2 Second offense (same day): ejection.
 - 9.1.2 Fighting
 - 9.1.2.1 First offense ejection
- 9.2. Dress code violation.
 - 9.2.1 Players are not allowed on the course if they are not properly dressed.
- 9.3 Course abuse
 - 9.3.1 First offense: warning.
 - 9.3.2 Second offense: 2 stroke penalty.
 - 9.3.3 Third offense: disqualification.
- 9.4 Slow play
 - 9.4.1 Coaches are to monitor the pace of play.

Section 10 - Dual Matches and League Tournaments

- 10.1 CVC competition will be for varsity only.
- 10.2 Boys will be play from the blue or back tees, girls will be play from the red or forward tees. The course may modify which tees are played.
- 10.3 Dual matches will be nine holes. League tournaments shall be 18 holes. Matches will be scored using medal play rules.
- 10.4 Teams shall be checked in and report to the first tee fifteen (15) minutes before starting time.
- 10.5 Section Team and individual qualifying

10.5.1 Performance Points

- 10.5.1.1 Each of the twelve players (six from each team) is awarded points for competing in a dual match. The best score receives twelve points with all other scores awarded in descending order. Points are averaged and split for those receiving identical scores.
- 10.5.1.2 Each player participating in a league tournament will receive points according to their finish. The best score receives 6 times the number of teams in the league with all other scores awarded in descending order. Points are averaged and split for those receiving identical scores.
- 10.5.1.3 Points accrued over the season from dual matches and tournaments, excluding the single lowest points score, will determine qualifiers for the section tournament and All Conference designation. Zero points will be awarded for not playing in or being disqualified from a match or league tournament. (For purposes of clarification, a zero score may be the score dropped)
- 10.5.2 The number of teams qualifying to the Section Tournament will be determined by the Section. Teams will qualify according to their total league finish.
- 10.5.3 Individual players, not a member of a qualifying team, shall advance to the Section Tournament as individuals.
 - 10.5.3.1 Ties among individuals, for the purpose of filling the allotted spots, will be played off in a sudden-death hole (or holes) playoff immediately following the second league tournament.
- 10.6 Rained out matches shall be rescheduled as soon as starting times are available.
- 10.7 If possible cancellations due to inclement weather should be made by the home coach by 12:00 Noon.
- 10.8 The host coach shall be responsible for explaining any "local rules" prior to the start of each match.
- 10.9 Disputes and Infractions
 - 10.9.1 Players are to questions an opponent's rule infractions.
 - 10.9.1.1 If there is a dispute, players in the groups shall try to reach a resolution prior to teeing off on the next hole. If a resolution cannot be reached, the dispute shall be noted on the scorecard and reported to the

coaches for resolution at the end of the match.

- 10.9.1.2 If a ruling is in question, player(s) shall play a second ball for the remainder of that hole. A ruling shall be made at the conclusion of the match by the coaches in accordance with USGA rules.
- 10.9.1.3 A rule infraction must be challenged on the hole the infraction occurred.
- 10.9.1.4 A rule infraction not challenged on the hole the infraction occurred will not be remedied.
- 10.9.2 If the coaches cannot agree on the proper ruling, no match results are to be released until a proper ruling can be obtained.
- 10.9.3 In the event the coaches cannot reach a resolution, the golf coordinator may make a ruling based upon USGA Rulings or he/she may refer the matter to the league ethics chairperson.

10.10 Scoring

- 10.10.1 Players are to exchange score cards and keep their opponents score. They are to keep their score on the card as well.
- 10.10.2 Players in a league tournament are to exchange score cards in a clockwise or counter clockwise manner and keep their opponents score. They are to keep their score on the card as well.
- 10.10.3 Players must announce their score following each hole.
- 10.10.4 If a score is disputed, players shall try to reach a resolution before moving to the next hole. If a resolution cannot be reached, record both scores and report the dispute to the coaches at the end of the match.
- 10.10.5 Players shall not sign a disputed score card.
- 10.11 Spectators must remain 30 yards away from competitors during both dual matches and tournaments. Spectators may not communicate with players.

Section 11 - Dress Code

- 11.1 Jeans may not be worn.
- 11.2 Shorts, hemmed at mid-thigh are permitted, no cut offs or short shorts.
- 11.3 All participants must wear a collared shirt. No pictures, offensive language

or symbols (other than team logos) are permitted.

- 11.4 Shirts must be properly worn at all times.
- 11.5 If hats are worn they must be worn properly (forward) and have no offensive language, pictures, slogans or symbols other than a manufacture's or team logo. No gang graffiti or any other modification may be made.

Section 12 - Miscellaneous - Activity Specific

- 13.1 Golf coaches are to supervise during league matches. If coaches choose not to play, they are to supervise the play on the course.
- 13.2 All players must take and pass the CVC approved etiquette test before they may compete in a league match.
- 13.3 Players may use a device which measures distance only during matches and tournaments and may share information relating to yardage. Players may not use any cell phone applications as the use of cell phones is prohibited during a round. The use of devices which measure other conditions, in addition to distance, that might affect a player's play (ie, wind or gradient) is not permitted, even if that feature is turned off. The penalty for breach of this rule is disqualification.

Section 13 - All Conference Selection

Revised: August 19, 2015

- 13.1 The ten (10) players with the highest number of Performance Points (see Section 10.5) scored during dual meets and league tournaments shall be selected to the all-conference team. The player with the most points shall be named MVP.
 - 13.1 The next ten (10) players with the highest number of performance points shall be designated as Second Team.
 - 13.1.1 If a tie exists, both will be named MVP.
- 13.1.2 If a tie exists for the 10th spot, the player with the best average score in the league tournaments will be awarded final spot.
- 13.3 All conference selections shall be forwarded to the league commissioner and to the media for distribution.
- 13.4 No all-conference team shall be selected below the varsity level.
